 - a. Correspondence and Notices:
 - b. GRRCD Grant Status Updates Lisa Hulette
 - Many of the grants are wrapping up and have been almost completely billed out such as the dairy, rangeland and sediment grants. The Salmon Creek and Green Valley draft plans have been mailed out for review. The Dutch Bill fish barrier project is progressing well. Sites are being mapped for the gorse removal grant. Invoices for the SOS grant are being paid. Bids will be going out next month for the Purrington Creek restoration grant. The insectories project is going well; Noelle and others have planted many pollinator plants.
 - c. Dairy Guidance Document (Review and Comments) Lisa Hulette
 - The Board was asked to review and provide comments on the dairy document. Joe
 Pozzi shared that the goal of the document was to provide a user friendly document
 which will help dairy farmers deal with regulators efficiently and get the information
 they need to achieve compliance.
 - d. Review and discussion of bids submitted for the Bodega Volunteer Fire Department (BVFD) Water Storage Tank:
 - Two bids were submitted for the BVFD water storage tank project: Piazza Construction and Bohen and Canelis. The Board reviewed the bids and voted for Piazza Construction.
 - e. Review and discussion of bids submitted for the Franceschi Fence Project
 - Three bids were submitted for the Franceschi Fence Project: Pruitt, Arrow, and Valatori. Valatori did not have the correct license so their bid could not be considered. The Board reviewed the bids and voted for Pruitt Fencing.
 - f. Green Valley Public Meeting on June 10, 2010 Lisa Hulette
 - Lisa gave the Board an overview of the public meeting to be held in June. She shared that this was as information meeting to discuss the Green Valley Watershed Management Plan and to review water rights. Lisa gave a brief review of the topics each speaker would be discussing.

- g. Set date for June 2010 GRRCD Tour of Project
 - It was decided that the GRRCD tour of projects will be set for some time in late June. This will be a half day tour with lunch provided by GRRCD.

h. Update on SOS Program

• John Green provided an update of the SOS program and the six activities that are part of this program:

Activity 1. Riparian revegetation: The plantings on the Ryan and lower Fay Creek properties are complete and are doing well. Plantings on Gillardy's property are almost complete.

Activity 2. Instream large woody debris (LWD) structures: PCI is working on the final designs for the LWD structures at Gillardy's property.

Activity 3. Stream flow augmentation: John has been doing site assessments for the stream flow augmentation projects in Salmon Creek. These include the BVFD tank, Gillardy's tank and the individual rain water catchment systems. Activity 4. Fine sediment management: The headcut repair at Gillardy's will be implemented soon.

Activity 5. Education and outreach: There are a few events coming up that will provide education and outreach about the SOS program in Salmon Creek. These include the GGRCD tour in June, an upcoming public meeting and the SRF Coho Confab in August.

Activity 6. Monitoring plan: John is planning to put in instruments in Salmon Creek that will measure depth, temperature and dissolved oxygen. These measurements will provide baseline data about water quality and quantity in the watershed. It is expected that in the future stream flow will increase and conditions for fish will improve.
