- b. GRRCD Grant Status Updates Lisa Hulette

GRRCD has received 6 IOUs so far, with 3.75% interest. Repayment on submitted invoices has a 24-hour turnaround time, an advantage of stimulus funding, despite its complexities. The SWRCB dairy grant is back online, requiring the development of a guidance document. Work on Harston, Colby, and Albini is underway, with fence installations completed today. The sites will be revegetated this winter. The DFG Purrington 2008 grant agreement was received, and work will start next year.

c. Discussion of stream augmentation and rainwater catchment tanks that are a component of NOAA ARRA Project – Lauren Hammack (Prunuske Chatham, Inc)

Several recent studies of the Salmon Creek Watershed have shown that late summer flow is the primary limiting factor for salmonids, necessitating the proposed efforts to construct rainwater catchment structures along the critical lower reach around the town of Bodega. This project was ideal for ARRA funding as the permit requirements are much less than for instream work. As part of the project, a 230,000-gallon geocell tank will be installed at Gilardi's, and will serve as a demonstration project to apply this technology to agriculture, as it is more commonly used in urban settings under asphalt parking lots. Tanks will also be placed at the Bodega Fire Department, and at landowners' homes, who will contribute a match. GRRCD should look into agricultural tax (2.5%) on materials.

d. Update on District-wide Water Quality Monitoring – Nick Crump/Brittany Heck

Water quality monitoring results from the Estero, Green Valley, Dutch Bill, and Salmon Creek were shared, and are included with the minutes.

e. Update on Dutch Bill Creek Dam Removal Project – Lisa Hulette

The dam removal is underway. Gasoline-soaked wood was uncovered at the base of the culvert apron, requiring hazmat and temporary suspension of construction. The concrete of the dam was unexpectedly double-reinforced, with 6-foot deep footing, and is requiring longer to remove than anticipated. PCI is meeting with the engineer to see if some of the footing can remain intact.
