 - a. Correspondence and Notices Strategic plan questionnaires and miscellaneous mail was given to Board
 - b. GRRCD Grant Status Updates Lisa Hulette
 - Staff reviewed the status of the current grants.
 - The Estero and Rangeland grants will be complete by December. Brittany has been
 working with Lee Erickson through the Rangeland grant to install a livestock crossing,
 and has ordered a no-till drill. Barry suggested we cover the cost of eventual
 replacement of the no-till, along with a charge to cover maintenance and staff time in the
 rental fee. RCD staff still needs to purchase a trailer.
 - PCI has finished up the pool feature at the Dutch Bill Dam site.
 - Staff are currently negotiating with the SCWA for the next RR Coho Cooperative Agreement, which will contain less funding than previously.
 - Construction through the DFG Purrington Creek project is complete; staff with the help from AmeriCorps volunteers will be installing a willow wall this November and be planting the site in December.
 - Preliminary design for workshops for on the 319(h) grant has begun.
 - The Green Valley Roads project is under way with the first property complete.

 Depending on weather construction crews plan to begin the next property this week.
 - All 10 classes for the SCAPOSD environmental education grant have scheduled their first field trip out to the Bianchi Dairy. They are scheduled to occur from the beginning of November until the 2nd week of December. Al suggested we contact the Dairy Women for help on the field trip days.
