This design project is funded by NOAA through the Sonoma County Water Agency and will consist of progress on design of a comprehensive water self-sufficiency project for the Alliance Redwoods Conference Grounds, in the Dutch Bill Creek watershed. The project was initiated by GRRCD through our participation in the Russian River Coho Water Resources Partnership. The funding provided by NOAA is not sufficient to complete the project design, but will enable us to make progress on it while we are looking for additional funding.

This grant will provide cost share funding for construction of these two projects, both of which are located in the Green Valley Creek watershed. The Redwood Hill Dairy project is already under construction using North Coast IRWMP funding, and the grant will provide additional cost share for project completion. The Campbell project is scheduled for construction in the summer of 2017, with primary funding provided through the Wildlife Conservation Board.
