Noel Bouck (Salmon Creek Watershed Council): The SCWC has been asked to write a letter of support for the West Sonoma County Collaborative Fuel Reduction Project, being submitted by Fire Safe Sonoma to CAL FIRE's Fire Prevention grant program. I have two questions about this proposal: First, how will the Project control soil erosion and sediment pollution to the local streams where it plans to create shaded fuel breaks along old logging roads? Second, what is the role of the RCD in this project?

Adriana Stagnaro (GRRCD Outreach and Project Manager) answered: To your first question, if funded, the first year of the five year project will be spent planning and conducting environmental review of the shaded fuel break projects. I'd be happy to talk more about this outside of the meeting. To your second

question, if funded, the Gold Ridge RCD will be contracted to support the environmental review process and collaboration between the grantee (Fire Safe Sonoma) and the landowners in the project area. The RCD may also be contracted for forestry work or to act as the project's CEQA lead, but this is yet to be determined.
